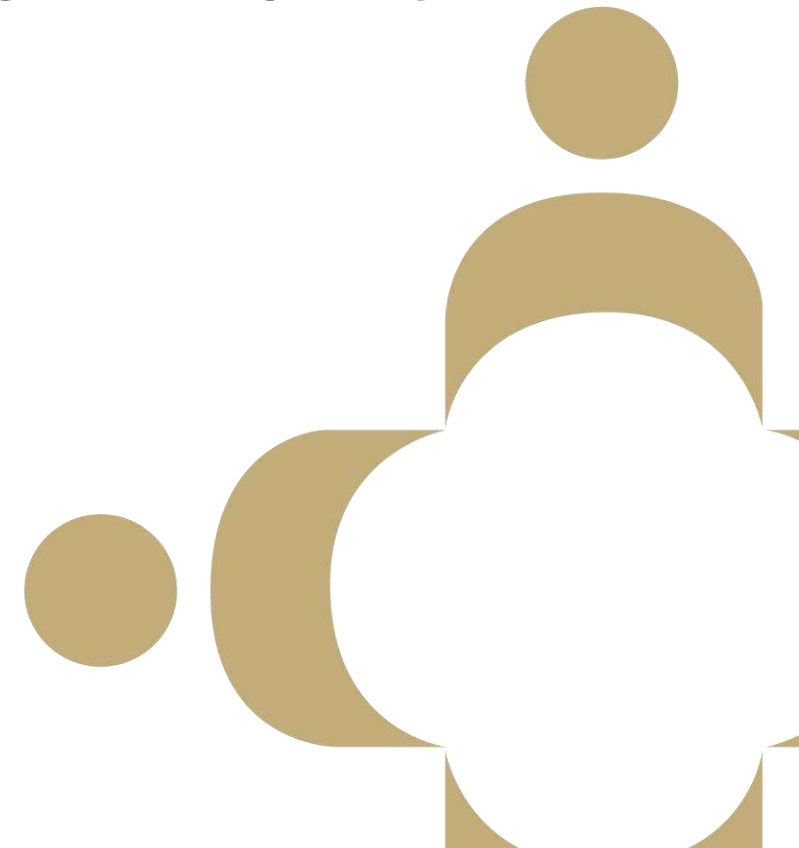

Recommendation Refinement

Please keep the following criteria in mind when refining recommendations for the 10-yr Action Plan with 1, 3, 5, and 10 year milestones:

- **Specific:** Who is responsible, and for what? Name a lead entity if possible.
- **Measurable:** How will we know if we have achieved success?
- **Achievable:** There needs to be a chance it can happen.
- **Results-oriented:** What does the outcome look like?
- **Time-Bound:** When should/will the activities and actions occur?
- **Clearly written:** Easy to understand.

Include an estimate of resources that will be required when possible.

- I. How will this recommendation impact health outcomes for mothers and infants in rural South Carolina?

- II. What is a realistic timeline to implement this?

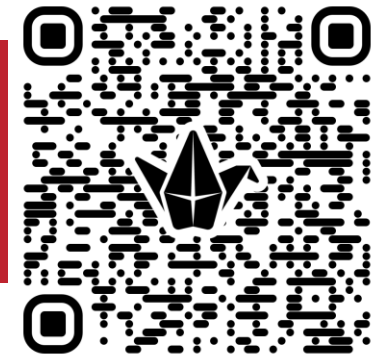
- III. Who are the key players or champions to support this idea and recommendation?
